Shalom to the Noahide and Jewish world community,

I am reaching out to you today due to some recent events that you may or may not be aware of but I wanted to share with you my side of this using actual evidence and let it do the majority of talking. If I'm not able to resolve this issue Noahide Nations will be shut down. I can no longer fight these types occurrences without some help from the Jewish and Noahide communities. Even if we must close down, in my heart I believe that we have accomplished much for a lot of people. I must thank you, for all you have done for Noahide Nations and I was truly blessed to have had the opportunity to be involved and be able to work with you in many of the successes.

Recently, Noahide Nations suffered a vicious attack from Fishel Todd of Yeshiva Pirchei Shoshanim with the assistance of Netiv of Houston and its upper management, and Google/YouTube. There may be another party involved who claims they knew nothing about this. They are aware of it now so only time will tell if they were truly involved or not.

Fishel Todd filed copyright claims on videos we have had on our YouTube channel. We had nearly 200 videos uploaded and years of work put into our YouTube channel. They do not hold the rights to these videos, we are the owners. Nonetheless, they convinced YouTube to permanently disable our channel. YouTube shut our channel down without any notice or providing a means to file a counter claim. For the past week or so I have been in communications with YouTube in an attempt to file a response but I am dealing with machines that all seem to have auto responders or individuals who just don't want to bother with it, but I believe it is the former. In any case nothing seems to work. Consequently, we seem to have no recourse to file a counter claim and our YouTube channel remains permanently disabled. The only notice we received was the "permanently disabled account" notice which prevents us from filing a formal counter claim.

There is quite a bit of documentation supporting Noahide Nations claim to these videos and beyond, in terms of copyrighted material. I must keep the majority of these private until I start hearing back from the many law firms I have contacted regarding this entire atrocity. Once I hear back from them with instructions I will see then if I can release the rest.

For now, I have attached a number of documents for your review and knowledge and to hopefully set the record straight. I also want to forewarn everybody of the nature of these people and their organizations. If you are currently involved with them you may want to reconsider that involvement and for those who are not involved with them you may want to steer clear of them.

Finally, even if Noahide Nations were guilty of copyright infringement the viciousness in which this attack came is nothing short of pure evil, with the intent to do harm and/or destroy Noahide Nations. It certainly is not Torah based.

In the event Noahide Nations must close down, after 17+ years, it was great to know and work with all of you. If you are aware of a good lawyer/Law Firm please send me their contact info. I am actively pursuing a good trial attorney.

These documents and images are as follows:

- 1) "Letter Regarding Noahide Nations & Pirchei." *Dated 2/18/2022* This is the letter that Rabbi Bloomenstiel sent out to the general public that has the Noahide and Jewish communities talking up a storm and giving Noahide Nations a questionable reputation.
- 2) "Avi Email NN Owns Videos" *Dated 2/15/2022* This image is of the recent email I received from R' Bloomenstiel in response to my email notifying him of what Fishel from Yeshiva Pirchei Shoshanim had done. It confirms that we own the videos because we paid for them. I also believe that we paid for the text as well due to payments we made to Mr. Bloomenstiel's wife, on his behalf shown in #7.
- 3) "Fishel Copyright Email" You will see that I highlighted who sent it as well as the attached document title.
- 4) "Copyright Assignment NOAHIDE LAWS" This is the actual copyright sent to me by Fishel Todd which is pictured in #3. In it there is a complete description of what Mr. Bloomenstiel assigned to Pirchei Shoshanim. It describes what the copyright is for, exactly. I highlighted all of it but the most important part of Exhibit A clearly states that the copyright is for the "PDF Text files" and nothing else. Not video, not audio, not a song, not anything except for the PDF text files. This is exactly what R' Bloomenstiel put in his email to me shown in #2. Why he makes the claim, in his letter, #1, that he doesn't know who has what, I will never understand.
- 5) This is an image showing that Yeshiva Pirchei Shoshanim is responsible for the take down of Noahide Nations YouTube Channel.
- 6) This is an image of YouTube permanently disabling the Noahide Nations account.
